

# 2024 Report under the Fighting Against Forced Labour and Child Labour in Supply Chains Act

# Introduction

This report has been prepared by **Sirius Instrumentation and Controls, Inc.** to comply with the requirements of *Canada's Fighting Against Forced Labour and Child Labour in Supply Chains Act* for financial year ending April 30, 2024.

## Structure, activities, and supply chain

Utilizing the practices, as outlined in this report, the management of Sirius Instrumentation and Controls Inc., assesses the risk of forced labour and child labour in its operations and supply chains to be low. The company is committed to maintaining a high standard with respect to the use of ethical labour initiatives within its operations and supply chain.
